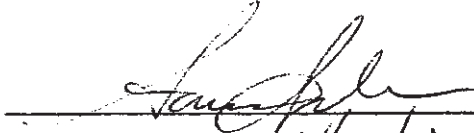

This Contract, made this 24<sup>th</sup> day of January, 2007, by and between Miami-Dade County, a political subdivision of the State of Florida (hereinafter referred to as "County") through its Department of Human Services (hereinafter referred to as "Department"), located at 2525 NW 62<sup>nd</sup> Street, 4<sup>th</sup> Floor, Miami, Florida 33147, and Suited for Success, Inc. having offices at 2650 Southwest 27<sup>th</sup> Avenue, Suite 302, Miami, FL 33133 (hereinafter referred to as "Provider") states conditions and covenants for the rendering of social and/or crime prevention services (hereinafter referred to as "Services") for the County.

WHEREAS, the Home Rule Charter authorizes the County to provide for the uniform health and welfare of the residents throughout the County and further provides that all functions not otherwise specifically assigned to others under the Charter shall be performed under the supervision of the County Manager; and

WHEREAS, the Provider provides or will develop services of value to the County and has demonstrated an ability to provide these services; and

WHEREAS, the County is desirous of assisting the Provider in providing those services and the Provider is desirous of providing such services; and

WHEREAS, the County has appropriated funds through Ordinances 06-130 and 06-131 for the proposed services; and

WHEREAS, the County has appropriated funds to the Provider for the proposed services,

NOW, THEREFORE, in consideration of the mutual covenants recorded herein, the parties hereto agree as follows:

**I. AMOUNT PAYABLE.** Subject to available funds, the maximum amount payable for services rendered under this Contract, shall not exceed \$37,500. Both parties agree that should available County funding be reduced, the amount payable under this Contract may be proportionately reduced at the option of the County.

**II. SCOPE OF SERVICES.** The Provider agrees to render services in accordance with the Scope of Services incorporated herein and attached hereto as Attachment A.

The Provider will implement the Scope of Services as described in Attachment A in a manner deemed satisfactory to the County. Any modification or amendment to the Scope of Services shall not be effective until approved by the Department in writing.

**III. BUDGET SUMMARY.** The Provider agrees that all expenditures or costs shall be made in accordance with the Budget which is attached herein and incorporated hereto as Attachment B.

Describe the organization's goal: Suited for Success (SFS) was established in 1994 as a nonprofit 501(c)(3) organization serving welfare recipients in Miami-Dade County. Over the last 12 years, SFS has assisted over 12,000 individuals enter the workforce. During this time, SFS has expanded its services, providing training and clothing to welfare-to-work participants, ex-offenders, transitional housing clients, low-income high school students, youth in the foster care system, and other individuals who are struggling to secure and retain employment. One little known fact about SFS is that approximately 83% of the individuals who receive clothing from the agency first participate in a job skills training program. SFS has offered job skills training since its inception and views these courses as a key to supporting clients in effectively securing employment. In 2006 SFS redefined its mission to better reflect how the services have evolved over the last decade. The mission of Suited for Success is to ensure that at-risk women, men, and teens in Miami-Dade County have the skills necessary to obtain gainful employment and achieve economic self-sufficiency.

Describe what is proposed for funding: Through this grant, Suited for Success will provide job skills training and clothes to low-income men and women from throughout Miami-Dade County. The clients who participate in this program are referred from social service agencies and are actively in the job search process. The training and clothes are key component to successfully securing employment.

Staff work closely with a variety of community organizations in order to effectively achieve positive outcomes for our clients. SFS currently has 5 staff members, 5 board members, approximately 20 volunteers annually, along with hundreds of individuals who support our programs through their in-kind clothing donations. With special skills and experience, staff bridge cultural and language gaps as they develop and strengthen partnerships, collaborations, and referral systems with government agencies, community service providers, schools, and businesses. SFS currently works with more than 60 external organizations in delivering its programs, and is continually developing its network of support. This strategy increases access for low-income job seekers to a variety of services, promotes the sharing of resources and knowledge, and encourages effective responses in meeting the needs of job seeking participants.
